### Retailer Tips

#### **Security Update**

Assorted scam artists are trying to take advantage of the unsuspecting, and often lottery retailers are targeted.

A recent scam involves a criminal who orders a large number of tickets, then asks the clerk for a rubber band, envelope, or anything else as a distraction. While the clerk is distracted, he switches the live tickets them with a stack of redeemed tickets and places a new ticket on top. He then comes up with an excuse, like claiming he left his wallet in the car, and walks out promising to return with money to purchase the tickets.

To prevent a loss like this, treat your tickets like cash and don't leave them accessible to the public. Even cashed tickets and coupons have value, and can be used by a criminal as in the in scenario outlined above. Additionally, retailers are encouraged to regularly track their Scratch ticket inventory. Stolen tickets can be tagged to prevent them from being cashed if the ticket numbers are known, and information about validation attempts on stolen tickets is useful in an investigation. Ticket inventory sheets are available in the Retailer section of the Nebraska Lottery website, nelottery.com.

#### Age Verification

Under legislation that went into effect on July 13, driver's licenses can be scanned to validate a customer's age for lottery purchases.

Introduced by Tekamah Senator Ken Rogert and passed 46-0, LB261 permits retailers selling alcohol, tobacco, or lottery tickets to collect and store driver's license numbers and state identification numbers by scanning barcodes on the back of identification cards. A retailer that stores this information should post a sign at the point of sale stating that the license or card will be scanned and that the age and identification number will be stored. Scanned information can be used by law enforcement only for the purpose of enforcing restrictions on age-sensitive products such as alcohol, tobacco, and lottery tickets.

It is important to always request a form of age verification if you suspect the player is not old enough. Nebraska statutes make it a criminal offense to sell Lottery tickets to a person under 19 years of age, or for someone under 19 years of age to purchase Lottery tickets or redeem Lottery tickets for prizes. A Lottery retailer can have their contract suspended and/or terminated if the Lottery determines that they have violated these restrictions. #### Latest Transfer A Sign of Continuing Success

While numbers can sometimes be confusing, I think the following information provides a pretty clear story.

Every quarter, I have the pleasure of updating you on the fruits of our collective labors on behalf of our beneficiary programs—in the form of the latest transfer of proceeds.

At the end of June, the Lottery transferred \$9,703,068 to its beneficiaries, which was distributed in the following manner:

**Education Innovation Fund, \$1,916,356**;

Nebraska Opportunity Grant Fund (formerly known as the Nebraska Scholarship Fund), \$2,401,509;

Nebraska Environmental Trust Fund, \$4,317,865;

Nebraska State Fair Support and Improvement Fund, \$970,307; and Compulsive Gamblers Assistance Fund, \$97,031.

A total of \$381,354,924 has been distributed in quarterly transfers since the Nebraska Lottery began operation on September 11, 1993.

That grand total has been distributed as follows:

**Education Innovation Fund, \$130,173,413**; Nebraska Opportunity Grant Fund, \$45,728,292; Nebraska Environmental Trust Fund, \$157,440,706; Nebraska State Fair Support and Improvement Fund, \$15,837,966; and Compulsive Gamblers Assistance Fund, \$8,713,551.

Amendment 4 passed by Nebraska voters in November of 2004 established the following distribution formula: Education as directed by the Legislature (44.5 percent) -- currently divided between the Education Innovation Fund and Nebraska Opportunity Grant Fund; Nebraska Environmental Trust Fund (44.5 percent); Nebraska State Fair (10 percent); and the Compulsive Gamblers Assistance Fund (1 percent, plus the first \$500,000 in fund proceeds each fiscal year).

For those keeping track of the math involved, note that prior to July 1, 1997, the Solid Waste Landfill Closure Assistance Fund received proceeds totaling \$18,460,996 and, in 2004, the Legislature directed that a one-time transfer of \$5 million be made to the State General Fund.

When the Nebraska Lottery was organized in 1993, it was estimated that annual sales would produce between \$10 million and \$15 million a year for beneficiary programs. Obviously, as we near the \$385 million mark in proceeds, it is clear that our sales and promotional efforts (the work we undertake together) are truly Helping To Build A Better Nebraska.

#### Free Quick Pick Ticket Wins \$146,000 Nebraska Pick 5 Jackpot

A free quick pick ticket turned out to be worth \$146,000 to Marvin Wilson of Lincoln, who recently won the jackpot playing Nebraska Pick 5 from the Nebraska Lottery.

Wilson received a free quick pick ticket from a previous play at Mill's Squeegee Fill, 800 North 17th Street in Lincoln. The ticket contained all five of the winning numbers (5, 15, 18, 26, 33) from the June 24 drawing for the \$146,000 jackpot.

While claiming his prize on June 26, Wilson told Nebraska Lottery officials that he usually waits to purchase Nebraska Pick 5 tickets until the jackpot is \$100,000 or higher. He learned he had won the jackpot prize after visiting the Nebraska Lottery website, nelottery.com. "The first thing I saw was that the jackpot went back down to \$50,000, and I thought, 'Somebody won it,'" said Wilson. He then checked his ticket against the winning numbers and realized he had won \$146,000. Wilson plans to save for retirement using his winnings.

The odds of winning the Nebraska Pick 5 jackpot, which starts at \$50,000 and grows by \$4,000 each drawing that it is not won, are 1 in 501,942. The overall odds of winning a prize in the game, which has drawings six nights a week, are 1 in 8.

#### Burwell Man Wins \$32,000 Playing Larry the Cable Guy®

Kerry Ballagh of Burwell won \$32,000 playing the \$5 Scratch game Larry the Cable Guy from the Nebraska

Ballagh purchased his winning Larry the Cable Guy ticket at Dad's Calamus East, 220 North 13th Street in Burwell. Scratching the ticket, he revealed matching symbols for a corresponding prize of \$32,000.

While claiming his prize on July 2, Ballagh told Nebraska Lottery officials that he couldn't believe he had won the top prize when he scratched off the ticket. "I

thought at first it was just a \$1,000 winner, but I kept on scratching," said Ballagh. He plans to pay bills and take a vacation using his winnings. The odds of winning the \$32,000 top prize are 1 in 96,000, while the overall odds of winning any prize are 1 in 3.66.
