The bill was passed by the Nebraska Legislature and signed into law by Governor Heineman on May 13.

For our retailers, the renewal of the hold harmless provision will allow us to continue to offer an additional 1% commission for Scratch ticket sales through our Retailer Merchandising Plan. If your store is currently signed up for this plan, your LSR will be contacting you soon to sign a new contract addendum to continue in the program.

With the hold harmless legislation, the Nebraska Lottery will continue to provide our customers with products they want to purchase while supporting good causes across Nebraska. Together with our retailers, we are truly Helping to Build a Better Nebraska.

### nebraska lottery a continuing success

As the seasons change from spring to summer and our fiscal year winds down, I think it's appropriate to look at some of the factors that have helped the Nebraska Lottery develop into a successful lottery over the past 16 years.

Since 1993, the Nebraska Lottery has striven to increase sales of our Lotto and Scratch products by providing quality entertainment options to Nebraskans. These increases have, in turn, allowed us to increase the support of our beneficiary funds working for the environment, education, the Nebraska State Fair, and Compulsive Gambler's Assistance.

A key factor in maintaining our sales figures has been the hold harmless legislation outlining the Nebraska Lottery's fiscal obligations to our beneficiary funds. The enabling legislation for the Nebraska Lottery specified that 25% of lottery proceeds were provided to our beneficiary funds. With the set percentage, we were unable to provide games with prize structures that our players prefer. Additionally, we were unable to expand our incentive programs for retailers.

The hold harmless legislation established in 2003 required the Nebraska Lottery to remit a minimum amount of \$20.2 million to the beneficiaries instead of 25% of lottery proceeds. This allowed us to use more of our revenue to grow sales while increasing our transfers to the beneficiary funds. Since the hold harmless legislation went into effect, yearly sales for the Nebraska Lottery have increased by almost \$30 million, and the average monetary transfer to the beneficiary funds has also increased.

A revision of the hold harmless legislation was needed this year because it was to sunset (expire) on June 30, 2009, causing us to revert back to a required 25% allocation. LB 286 was introduced during this year's legislative session to renew the hold harmless and make the provision permanent.

The truck prize is valued at \$44,000, which includes \$1,227 for costs associated with ownership and state and federal withholding paid by the Nebraska Lottery of \$2,200 and \$11,000, respectively. The odds of winning the top prize in Truck\$ & Buck\$ are 1 in 150,000, while the overall odds of winning any prize are 1 in 3.61.

### help recover missing children

The Nebraska Lottery has assisted law enforcement agencies since 2002 as part of the AMBER Alert response network. Because time is critical in abduction cases, Nebraska Lottery retailers and players will be notified of AMBER Alerts through our statewide terminal network.

In the event of an AMBER Alert, the Nebraska Lottery will send a terminal message to all Nebraska Lottery retailers. This message is mandatory and must be read immediately in order to continue with normal terminal operations. Additionally, "AMBER ALERT" will flash on the Starlite electronic message sign located with Nebraska Lottery terminals to help call attention to the urgent situation.

The Nebraska Lottery has revised the retailer AMBER Alert poster to better inform customers at your store of a current alert. The poster has a sleeve to display the AMBER Alert terminal message, and outlines the procedure to follow in an AMBER Alert situation. If you would like a new poster, please contact your LSR.

AMBER Alert terminal messages will come every 30 minutes for the first three hours of the alert. We encourage you to print extra copies of the alert and place these copies in a prominent location for customers to pick up. Additional information or cancellations will be sent via terminal message within 24 hours.

As part of the AMBER Alert network, Nebraska Lottery retailers play an important role in the safe return of missing or abducted children. Providing this information to customers dramatically increases the number of people that are on the lookout for children in potentially dangerous situations, and is another example of how together we are Helping to Build A Better Nebraska.
